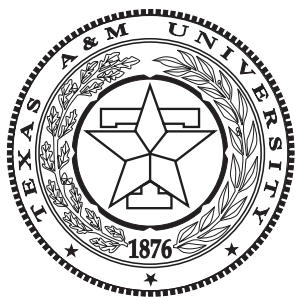

F. Philip Manns Jr. is a Professor of Law at Liberty University School of Law. Prior to joining the Liberty faculty in 2006, Professor Manns was part of the law faculty at California Western School of Law in San Diego. Professor Manns' areas of teaching include: Wills, Trusts, and Estates; Taxation; Estate Planning; and Business Planning. He has served as a public arbitrator for the National Association of Securities Dealers and as a Site Evaluator for the ABA Section on Legal Education and Admissions to the Bar. Prior to entering Academia, Professor Manns practiced tax law at King & Spalding and clerked for the Honorable Francis D. Murnaghan, Jr. at the U.S. Court of Appeals for the Fourth Circuit. Calvin Chestnut Prize for outstanding scholastic achievement.

Timothy Todd is the Associate Dean for Academic Affairs and an Associate Professor at Liberty University School of Law. His areas of teaching include: Individual Income Taxation; Mergers and Acquisitions; Business Planning; and Bankruptcy. Prior to entering Academia, Professor Todd clerked for the Honorable Eric G.
