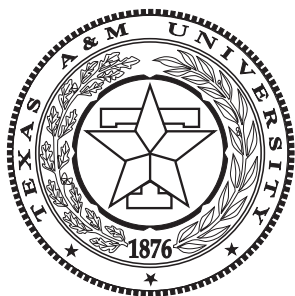

Marsha Griggs

Building a Better Bar Exam

Marsha Griggs is an Associate Professor of Law at Washburn School of Law where she is the Director of Academic and Bar Support. She teaches Multistate Legal Analysis and Law in Context. Ronald J. Colombo

Taking Stock of the Benefit Corporation

Professor Colombo teaches a variety of corporate and securities law courses at Hofstra Law School. His scholarship has focused largely on issues of securities fraud, corporate law, financial regulation, and, more recently, the constitutional rights of business organizations. In 2015 he authored a book on the subject, entitled *The First Amendment and the Business Corporation*, published by Oxford University Press. From 2013–2015, he served as the Law School’s Associate Dean for Academic Affairs. He currently serves as the School’s Associate Dean for Distance Education. Before joining the Hofstra faculty in 2006, Professor Colombo served as vice president and counsel for Morgan Stanley & Co., Inc. Prior to that, Professor Colombo practiced as a litigation associate at the New York office of Sullivan & Cromwell. Professor Colombo graduated, *magna cum laude*, from NYU School of Law. He was a member of the Law Review and was elected to the Order of the Coif. He clerked for The Honorable Judge Jerry E. Smith of the U.S. Court of Appeals for the Fifth Circuit immediately following graduation.

Daniel J. Morrissey

The EU’s Struggles With Collective Action for Securities Fraud: An American Perspective

Daniel J. Morrissey is a professor and former Dean at Gonzaga University Law School in Spokane, Washington. He holds both a bachelor’s (Phi Beta

Kappa) and law degree from Georgetown University. After law school he served as a clerk for a United States district judge in Chicago and then worked in the Division of Enforcement at the Securities and Exchange Commission. After a period of time in private practice at what is now the Los Angeles office of K&L Gates, he became a law professor at the University of Tulsa where he earned the rank of tenured full professor. He has also been a visiting professor at Pepperdine University Law School, the University of Denver, Seton Hall University, DePaul University, and New York University Law School as well as an adjunct professor at Loyola Law School in Los Angeles.

Professor Morrissey has served terms as Dean at both St. Thomas University Law School in Miami and at Gonzaga. He has published a number of articles in the areas of corporate/securities law and jurisprudence. He is most recently the co-author of a casebook on Securities Litigation that was published in 2016 by Carolina Academic Press. He has also served as a consultant and expert witness in a number of cases involving issues of corporate and securities law.

Brian Elzweig

Unintended Consequences, Loopholes, and Gibberish: Why There Are Still Securities Act Class Actions in State Courts

Brian Elzweig is an Associate Professor of Business Law at the University of West Florida. In 2018 he was named as a research fellow to the Reubin O'D. Askew Institute for Multidisciplinary Studies. He received a J.D. from California Western School of Law and an LL.M. in Securities and Financial Regulation from Georgetown University Law Center. His research has been published in many legal and business journals including the Oregon Law Review, the William & Mary Business Law Review and the Pace Law Review. His research has been cited by the Federal Claims Court and the United States District Court for the Northern District of Ohio. Additionally, he has been interviewed or his research has been quoted by major popular press outlets such as the Washington Post, the Huffington Post, the Dallas Morning News, the Houston Chronicle, and the Kansas City Star.

Ilya Rudyak

Promoting Equality Through Empirical Desert

Ilya Rudyak served most recently as the Legislative Director of the Delaware Criminal Code Improvement Project, commissioned by the State of Delaware from the University of Pennsylvania Law School's Criminal Law Research Group, where he was a Fellow. Prior to that, he served as the Director of Research at the Center for Ethics and the Rule of Law, the national-security center of the University of Pennsylvania Law School. Earlier he practiced commercial and criminal litigation at a leading law firm in Israel, conducted experiments in a social psychology laboratory, worked as an educator at the International School for Holocaust Studies, Yad Vashem, and served as the Head of Weapons Department aboard an Israeli Navy submarine. Ilya earned his LL.M. degree from the University of Pennsylvania Law School and his joint LL.B. in law and psychology from

the Hebrew University of Jerusalem Faculty of Law. He is currently an S.J.D. candidate at the University of Pennsylvania Law School, and his research focuses on the theory, doctrine, and codification of criminal law and international humanitarian law.

Kristi Harbord
