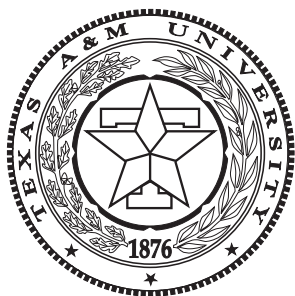

Bruce A. Green

Should Prosecutors Be Expected to Rectify Wrongful Convictions?

Bruce A. Green is the Louis Stein Chair at Fordham University School of Law, where he directs the Stein Center for Law and Ethics. He teaches and writes primarily on legal ethics and criminal procedure. Before joining the Fordham faculty, Professor Green served as a law clerk to Judge James L. Oakes and Justice Thurgood Marshall. He also served as an Assistant United States Attorney for the Southern District of New York. His service to the legal profession has included chairing the ABA Criminal Justice Section, the ABA Criminal Justice Standards Committee, and the ethics committees of the NY State Bar Association, the NYC Bar, the ABA Criminal Justice Section, the ABA Litigation Section, and the AALS. Additionally, he received the ABA's Michael Franck Professional Responsibility Award in 2018.

Michael L. Perlin

"In These Times of Compassion when Conformity's in Fashion": How Therapeutic Jurisprudence Can Root Out Bias, Limit Polarization and Support Vulnerable Persons in the Legal Process

Michael L. Perlin is Professor of Law Emeritus at New York Law School (NYLS), where he was director of NYLS's Online Mental Disability Law Program, and director of NYLS's International Mental Disability Law Reform Project in its Justice Action Center. Professor Perlin is also co-founder of Mental Disability Law and Policy Associates. Professor Perlin has written 35 books and over 300 articles on all aspects of mental disability law. His work focuses primarily on issues related to criminal law and procedure, therapeutic jurisprudence, and international human rights. Professor Perlin has done advocacy work on every continent and has litigated at every court level, from police courts to the U.S. Supreme Court. He is the honorary life president of the International Society for Therapeutic Jurisprudence and a member of that society's current Board of Trustees. He is also a member of the Lawrence Township (NJ) Community Concert Band, the Temple University Night Owls Band, the Mercer County Symphonic Concert Band, and the board of directors of the Washington Crossing (NJ) Audubon Society.
