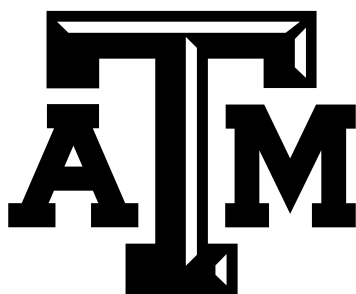

Richard A. Epstein

A Modern Defense of Simple Rules for a Complex World

Richard A. Epstein is the Laurence A. Tisch Professor of Law at New York University. From 1972 to 2010, he taught at the University of Chicago Law School. Since 2000, he has also been the Peter and Kirstin Senior Fellow at the Hoover Institution. Between 1981 and 1991, he served as the editor of the *Journal of Legal Studies*, and between 1991 and 2001, he served as an editor of the *Journal of Law and Economics*. He has written and taught in numerous fields. His books include: *The Classical Liberal Constitution: The Uncertain Question for Limited Government* (Harvard 2014); *Simple Rules for a Complex World* (Harvard 1995); and *Takings: Private Property and the Power of Eminent Domain* (1985). He has been a member of the American Academy of Arts and Sciences since 1985. He has received an LL.D., h.c. from the University of Ghent in 2003 and the University of Siegen in 2018. He won the Bradley Prize in 2011 and received the Norman McLean Great Teachers Award from the University of Chicago in 2014.

Cynthia Estlund

Employment-at-Will: Too Simple for a Complex World

Cynthia Estlund is the Catherine A. Rein Professor at the New York University School of Law. She has published widely on the law governing work and labor, including four books—*Automation Anxiety: Why and How to Save Work* (Oxford, 2021); *A New Deal for China's Workers?* (Harvard, 2017); *Regoverning the Workplace: From Self-Regulation to Co-Regulation* (Yale, 2010); and *Working Together: How Workplace Bonds Strengthen a Diverse Democracy* (Oxford, 2003)—and over eighty articles, book chapters, reviews, and essays. She has previously taught at the University of Texas School of Law, Columbia Law School, and Harvard Law School.

Lee Anne Fennell

Optional Price Discrimination

Lee Anne Fennell is the Max Pam Professor of Law at the University of Chicago Law School, where she has taught since 2007. Her teaching and research interests include property, torts, land use, housing, social welfare law, state and local government law, and public finance. She is the author of *The Unbounded Home: Property Values Beyond Property Lines* (Yale University Press 2009) and *Slices and Lumps: Division and Aggregation in Law and Life* (University of Chicago Press, 2019), as well as many articles and essays.

Rebecca Hansen*Toward Principled Background Principles in Takings Law*

Rebecca Hansen is a law clerk for Judge Vince Chhabria on the U.S. District Court for the Northern District of California. Her research interests include court procedure, the Takings Clause, and constitutional law, and her scholarship has appeared in *The University of Chicago Law Review*. She graduated with High Honors from the University of Chicago Law School, where she served as a Comments Editor for *The University of Chicago Law Review*. She received her B.A. from Brown University.

Richard L. Revesz*Fallacies in the Design of Climate Change Policies: A Response to Richard Epstein*

Richard L. Revesz is the AnBryce Professor of Law and dean emeritus at the New York University Law School. He is one of the nation's leading voices in the fields of environmental and regulatory law and policy, and has published ten books and 80 articles in major law reviews and journals on the subjects. In 2008, Revesz founded the Institute for Policy Integrity, a think tank and advocacy organization that promotes desirable climate change and environmental policies. Between 2014 and 2023, Revesz was also the director of the American Law Institute. Since January 2023, he has been on a public service leave serving as the administrator of the Office of Information and Regulatory Affairs, which is part of the White House Office of Management and Budget. He graduated summa cum laude from Princeton University, earned a master's degree in environmental engineering from the Massachusetts Institute of Technology, and received a law degree from Yale Law School, where he was Editor-in-Chief of *The Yale Law Journal*. He previously clerked for Chief Judge Wilfred Feinberg on the U.S. Court of Appeals for the Second Circuit and Justice Thurgood Marshall on the U.S. Supreme Court.

Lior Jacob Strahilevitz*Toward Principled Background Principles in Takings Law*

Lior Jacob Strahilevitz is the Sidley Austin Professor of Law at the University of Chicago. His research interests include property law, privacy law, consumer contracts and dark patterns, law & psychology, and law & technology. Along with the late Jesse Dukeminier, Jim Krier, Greg Alexander, and Michael Schill, he is a co-author of the most widely used property law casebook in the United States, which is now in its tenth edition, as well as several other books. He received his BA in political science from the University of California at Berkeley in 1996, graduating with highest honors. He received his JD in 1999 from Yale Law School, where he served as Executive Editor of *The Yale Law Journal*. Following his graduation, he clerked for Judge Cynthia Holcomb Hall on the U.S. Court of Appeals for the Ninth Circuit. He then practiced law in Seattle before joining the University of Chicago faculty in 2002. He was tenured in 2007 and served as the Law School's Deputy Dean from 2010 to 2012. In 2011, he was named the inaugural Sidley Austin Professor of Law. He was

elected to the American Law Institute in 2015. He is a two-time winner of the University of Chicago Law School graduating students' award for teaching excellence.

Franita Tolson

The "Independent" State Legislature in Republican Theory

Franita Tolson is Interim Dean and the George T. and Harriet E. Pflieger Chair in Law at the University of Southern California Gould Law School. She also holds a courtesy faculty appointment in the Political Science and International Relations Department at the USC Dornsife College of Letter, Arts and Sciences. Her scholarship and teaching focus on the areas of election law, constitutional law, legal history, and employment discrimination, and her research has appeared or will appear in many leading law reviews. Tolson is one of the coauthors of the leading election law casebook, *The Law of Democracy* (Foundation Press, 6th ed., forthcoming 2022), and her forthcoming book, *In Congress We Trust?: Enforcing Voting Rights from the Founding to the Jim Crow Era*, will be published in 2023 by Cambridge University Press. She has testified before Congress numerous times on voting rights issues and authored a legal analysis for an amendment to the U.S. Constitution that would explicitly protect the right to vote, in addition to serving as an election analyst for CNN and co-hosting an election themed podcast, "Free and Fair with Franita and Foley," with Ned Foley of The Ohio State University Moritz College of Law. She clerked for Judge Ann Claire Williams on the U.S. Court of Appeals for the Seventh Circuit and Judge Ruben Castillo on the U.S. District Court for the Northern District of Illinois. Tolson is a graduate of the University of Chicago Law School, where she was the Walter V. Schaefer Visiting Professor of Law during the Spring 2021 academic quarter.
