NCAA v. Alston and the Future

Jeffrey Kessler is a partner and Co-Executive Chairman of Winston & Strawn, LLP and the co-chair of its antitrust and competition practice. Meg Penrose

Meg Penrose is a Professor of Law at the Texas A&M University School of Law. She attended law school at the Pepperdine School of Law where she graduated *magna cum laude* and she received an LL.M. in International Human Rights from the University of Notre Dame where she graduated *summa cum laude*. Penrose clerked for the Honorable Judge Jerry Buchmeyer of the United States District Court for the Northern District of Texas during the 1993-'94 term and worked as a staff attorney to the Honorable Magistrate Judge—now U.S. District Judge—Jane J. Boyle, also of the United States District Court for Texas. Before teaching at Texas A&M, she was a Professor of Law at the Texas Wesleyan School of Law and the University of Oklahoma College of Law.

Jodi S. Balsam

Jodi S. Balsam is a Professor of Clinical Law and Director of Externship Programs at Brooklyn Law School. She is also an Adjunct Professor of Law at the New York University School of Law. Balsam received her Bachelor's Degree from Yale University and her J.D. from the New York University School of Law. After law school, Balsam clerked for the Honorable Chief Judge Charles L. Brieant on the United States District Court for the Southern District of New York and the Honorable Chief Judge Dennis Jacobs on the United States Court of Appeals for the Second Circuit. She is an independent arbitrator on the NCAA's Independent Resolution Panel and was formerly counsel for operations and litigation at the National Football League. She contributes, edits, and provides on-air commentary to the NBC/Universal Sports Group, Law360.com, LawInSports, and the *Journal of Legal Aspects of Sport*.

Michael A. Carrier

An Antitrust Analysis of the NCAA Transfer Policy

Michael A. Carrier is a Board of Governors Professor of Law at the Rutgers University Law School and a leading authority in antitrust and intellectual property. Carrier received his Bachelor's Degree, *summa cum laude*, from Yale University and his J.D., *cum laude*, from the University of Michigan School of Law where he was the Book Review Editor of the *Michigan Law Review*. He clerked for the Honorable Judge John D. Butzner, Jr., on the United States Court of Appeals for the Fourth Circuit. He advised the 2020 Biden-Harris presidential campaign on policy issues, served on the ABA Antitrust 2016 Presidential Transition Task Force, and co-authored a leading intellectual property and antitrust treatise: *IP and Antitrust: An Analysis of Antitrust Principles Applied to Intellectual Property Law*.

Marc Edelman

Marc Edelman is a Professor of Law at the Zicklin School of Business, Baruch College, City University of New York and an Adjunct Professor of Law at the Fordham University School of Law. Edelman graduated *magna cum laude* from the University of Pennsylvania Wharton School of Business, holds Master's Degrees from the University of Michigan and Baruch College, and received his J.D., *cum laude*, from the University of Michigan School of Law. In 2023 he was a Fulbright Scholar at the University of Canberra and he is the Director of Sports Ethics at the Robert Zicklin Center for Corporate Integrity. He co-authored *Esports and the Law: A Game Plan for Legal and Business Trends* and *Careers in Sports Law*.

Roberto L. Corrada

College Athlete Unionization

Roberto L. Corrada is a Professor of Law and Mulligan Burleson Chair in Modern Learning at the University of Denver Sturm College of Law. He received his Bachelor's Degree from the George Washington University and his J.D. from Catholic University of America Law School where he was Editor-in-Chief of the *Catholic University Law Review*. Corrada is a member of the American Law Institute and the Co-Founder and Co-Chair of the Advisory Board of the Denver Urban Debate League. He has testified in front of the United States Senate Committee on Labor and Human Resources, the Colorado Senate Judiciary Committee, and the United States NAFTA Panel. In 2018 he was elected as a fellow to the College of Labor and Employment Lawyers.

Bruce A. Green

Good Lawyers, Good Sports?: The Professional Identity of Sports Lawyers Representing Not-for-Profit Entities

Bruce Green is the Louis Stein Chair of Law at the Fordham University School of Law and the Director of the Louis Stein Center for Law and Ethics. Green was awarded his Bachelor's degree, *summa cum laude*, from Princeton University and his J.D. from the Columbia University School of Law where he was a James Kent and Harlan Fiske Scholar and an Associate Editor of the *Columbia Law Review*. After graduating, he served as a law clerk for the Honorable Judge James L. Oakes on the United States Court of Appeals for the Second Circuit and to the Honorable Justice Thurgood Marshall on the United States Supreme Court. Before coming to Fordham, Green was an Assistant United States Attorney and the Chief Appellate Attorney at the Office of the U.S. Attorney for the Southern District of New York. He is a member of the Board of Trustees of the Federal Bar Council and Chair of the MPRE Drafting Committee of the National Conference of Bar Examiners.

Michael A. McCann

New Amateurism

Michael A. McCann is a Professor of Law and Founding Director of the Sports and Entertainment Law Institute at the University of New Hampshire Franklin Pierce School of Law. In Fall 2023, McCann was a Visiting Professor of Law at the Harvard Law School. At the Franklin Pierce School of Law he created the first ever law school course on name, image, and likeness. McCann earned his Bachelor's Degree, *magna cum laude*, from Georgetown University, his LL.M. from Harvard Law School, and his J.D. from the University of Virginia School of Law where he was Editor-in-Chief of the *Virginia Sports and Entertainment Law Journal*. McCann is a leading scholar on sports law, co-author of *The Oxford Handbook of American Sports Law*, and an award-winning journalist on the staff of Sportico.
